- Fire Drills and Earthquake drills;
- New positions being posted for science technology engineering and math (STEM) and a \$2.1million grant received;
- State Boarding Home Allotment increase and we can use this to keep our students in our own district;
 - Maurice McGinty: Disappointed in the fact that members of the community that sit on the CSC who send students away to boarding schools. This has a knock on effect where kids come back and recruit other students to leave their villages. The intent of the REAA is to keep kids in the villages in their home culture.
 - o Dian Gurtler: Our own teachers have students outside of the district.
 - Shirley Kruger: Can we add a clause to the contract to make sure district teachers keep their kids in our schools?
 - o Kerry Boyd: We cannot legally do this.
 - o Maurice McGinty: We cannot legally do this.
 - o Ruth Folger: My grandkids say that school in the urban areas of Alaska is easier than it was in Minto.
 - o Maurice McGinty: Students go away for a better education but we provide a good quality education. We do not have the extra-curriculars other places have.
- Statewide initiatives
 - o Reading bill
 - Superintendents Meeting with Commissioner regarding retaining students;
 Department of Education is working on a bill that contains a retention component; discussion of retention of students and retention for the purposes of holding students back a grade level.
 - Dian Gurtler: Opposed to the idea that students cannot read in cursive;
 Cursive will become like Native Language;
 - Shirley Kruger: Has an 11-year old who cannot write in cursive and cannot read in cursive;
 - Fred Bifelt: We need to look at this holistically and undiagnosed learning disabilities;
 - Discussion around teaching of cursive
 - DEED has contracted with a retired Superintendent about putting in place a statewide virtual school.
